NOTICE

Subject : Mechanism for consideration of proposals for recognition to new / alternative systems of medicine.

This has reference to the 'Notice', dated 28.02.2017 (reference no. V.25011/436/2016-HR), which is available on this website under the caption "Alternative Systems of Medicine & Therapy" under the icon "Acts & Circulars".

2. The said 'Notice' prescribes the broadmanner in which a proposal, seeking recognition of an alternative system of health care, is to be formulated and submitted, for examination by the 'Inter-Departmental Committee for identifying viable new systems of medicine / therapy' (IDC). It has now been recommended by the IDC that, in addition to such proposals being formulated and submitted in the manner as advised in the said 'Notice', such proposals must also be adequately justified under each of the following seven criteria :

Essential Criteria

- The system should have its own fundamental principles of health and disease, which must differ in concepts from those of recognised systems in the country. It should be a comprehensive system of health care and not restricted to few diseases only.
- Substantial literature on concepts, aetiology, diagnosis and management of diseases like textbooks including Pharmacopoeia and Formularies and preferably journals if any, should be available in the country of origin or in other countries where it is currently practised.



- Information on whether it is recognised officially as a system of medicine in the country of origin and / or in any other country where it is currently practised.
- Documented information on uniqueness of modalities of treatment may be drugs, devices or any other methods such as diet, massage, exercise, etc.
- Standardised methods of preparation of Drugs / Devices used in the therapy and quality control procedures should be available.

Desirable Criteria

- Prescribed criteria for admission, curricula and training and details of such courses and list of teaching institutions in India / countries where it is a currently recognised system of medicine.
- Details of continuing medical education programmes and available research facilities.

3. In view of the above, any person or body, while forwarding proposals, seeking recognition to new, i.e., alternative systems of medicine, for examination by the said Inter-Departmental Committee, should ensure the requirement, mentioned at para-2 above.

CRITERIA FOR EXAMINATION OF ALTERNATIVE SYSTEMS OF MEDICINE

NOTICE

Subject : Mechanism for consideration of proposals for recognition to new / alternative systems of medicine.

This is to state, for information of all concerned, that the Department of Health Research, in the Ministry of Health and Family Welfare, Government of India, has been receiving, from time to time, miscellaneous references / representations from various individuals / bodies for according recognition to alternative systems of medicine.

2. In this connection, it may be stated that the Ministry of Health and Family Welfare and the Ministry of AYUSH are regulating different matters relating to various systems of medicine in the country. At present, the modern system of medicine is regulated through the Indian Medical Council Act 1956; the Homoeopathic System of Medicine is regulated through Homoeopathy Central Council Act, 1973 and the four Indian Systems of Medicine, namely Ayurveda, Siddha, Sowa Rigpa and Unani, are regulated through the Indian Medicine Central Council Act, 1970. Yoga and Naturopathy are also systems recognized under the Ministry of AYUSH, Government of India. However, there is no legal framework for recognizing and regulating any other new (i.e., alternative) systems of medicine.

3. The question of bringing in a separate Central legislation to facilitate grant of recognition to new, i.e., alternative systems of medicine, has been under consideration of the Union Government for quite sometime. After comprehensive consideration of the matter in the Government, it has now been decided to put in place a mechanism, in which, in lieu of a Central legislation, an Inter-Departmental Committee, comprising representatives from Central and State Governments, some regulatory bodies and persons of repute from the field of health sciences, will analyse and examine proposals seeking recognition to alternative systems of medicine, in order to establish the viability, or otherwise, of such systems for their safe adoption in the national healthcare system. This Inter-Departmental Committee will examine those proposals for recognition of systems of medicine, concept of which is quite independent of the existing recognised systems of medicine, namely, Allopathy system and AYUSH system. Recommendations that may be made by such committee would, thereafter, be considered by the Central Government in order to decide if such systems are viable and safe, and can be suitably notified by way of executive orders.


4. The terms of reference and scope of work for the Committee will be as under:
- (a) To invite *via* website, proposals / suggestions from various stakeholders / public / supporters / promoters of alternative systems of medicine, seeking recognition to any new system(s) of medicine, also calling for from them relevant documents / literature with respect to origin and history of such systems, including stages of its development and research works on it, etc., indicating the clinical applicability, efficacy and, above all, safety of such alternative systems, list of institutions providing teaching / trainings on that system / mode of therapy, curriculum, lists of experts, published documents available in public domain, etc.
 - (b) To analyse and examine each such application / proposal, and take a decision in respect to viability of notifying the alternative system; and
 - (c) To make recommendations to the Central Government for inclusion of any such system(s) in the list of viable systems of alternative medicine. While doing so, the Committee would also suggest suitable course / curriculum / regulatory body for each such system.
5. There will be pooling of proposals, thus received, for every quarter (ending 31st March, 30th June, 30th September, 31st December) for processing.
6. In view of the above, any person or body may forward proposals, seeking recognition to new, i.e., alternative systems of medicine, for examination by the said Inter-Departmental Committee. While doing so, they must invariably ensure the following requirements:
- (a) Proposal should be quite detailed and complete in all respects in terms of para- 4(a) above.
 - (b) Two hard copies of the proposal may be forwarded to the Department of Health Research at the address, given below.
 - (c) In addition, soft copy of 6(b) above must invariably be forwarded simultaneously or immediately thereafter.
 - (d) It may be noted that the proposal will not be entertained in case both 6(b) & 6(c) above are not forwarded.
 - (e) The proposals thus received, and which are complete in all respects, will be placed before the said committee for their consideration in due course of time, in the manner indicated at para-5 above.
 - (f) The sender (s) of the proposal(s) are likely to be invited to the meeting of the committee, as and when the committee sits, to present their proposal before the committee. They may also be required to make power-point presentation and /or any other demonstration before the committee, as may be required by the Committee. This will be intimated to the senders at the appropriate time. Further, they

will be expected to provide all information / material to the committee, as may be asked for by the committee. In addition, in case there is more than one body / person forwarding proposals for the same system, they may be advised to interact with each other and send one consolidated proposal to facilitate administrative convenience and smooth processing of the proposal. In such a situation, representatives of all such bodies /persons may be invited to the meeting of the committee to plead their case.

- (g) The proposals should be accompanied with full postal address (including 'Pin Code Number') and other contact details (telephone / mobile number, e-mail ID, etc.) of the sender(s).
- (h) No canvassing in favour of their proposal(s) should be resorted to outside the scope of the meeting of the committee. They will get ample opportunity to justify their case before the committee, when they are invited to attend the meeting.
- (i) Normally, no representation against the decision of the Committee as well as that of the Government, regarding viability or otherwise of the proposal, will be entertained.
