Subject: Engagement of Young Professionals in the Department of Health Research – reg.

An advertisement dated 08.07.2024 was published inviting applications for the post of Young Professionals (YPs) in the Department of Health Research. As per the circular, Young Professionals under four categories were to be engaged, which are:

ii.	05 (Five)	Two year Post Graduate Diploma in Management or MBA
iii.	02 (Two)	LLB or LLM
iv.	02 (Two)	B.E/B.Tech

2. Applications received against this advertisement were screened and online interviews were conducted for shortlisted candidates by the Selection Committee.

3. Department of Health Research received more than 1200 applications for the post of Young Professionals. National Productivity Council (NPC), an autonomous body under Dept for Promotion of Industry and Internal Trade (DPIIT), was engaged for providing recruitment assistance in view of the large number of applications. To evaluate and shortlist the applications, an experience-based criteria was adopted, as normally done by various recruitment bodies including the UPSC. The applicants shortlisted for interview were 10-12 times the number of available positions in each of the 04 categories of YPs.

4. The Selection Committee conducted interviews of the shortlisted candidates as per the following details:

Category	Interview details*
YP (Management)	interviews of the 46 applicants were held on 8 <sup>th</sup> and 9 <sup>th</sup> April 2025. 30 appeared for interview through VC.
YP (Legal)	interviews of all 25 applicants were held on 28.01.2025. 18 applicants appeared for the interview (through VC)
YP (B.tech)	interviews of 24 applicants were held on 27.01.2025. 18 applicants appeared for the interview through VC.

\* the interview for YP (research)- 10 posts, is yet to be conducted.

5. Upon interview, the committee recommended candidates for the posts of YP as per list at annexure-I. The Committee has also recommended candidates to be kept in reserve panel (list at annexure-II) for any vacancy arising due to non-joining, resignation etc. of the candidates mentioned above. The reserve panel will be valid for a period of one year.
