## INVITATION for EXPRESSION OF INTEREST (EOI)

1. This is an invitation from Health Technology Assessment India (HTAI) Department of Health Research for submission of Expression of Interest for Establishment of new HTA Resource centres for Undertaking Health Technology Assessment Studies.
2. DHR intends to establish Resource centres for HTAI across India in the year 2025-26
3. The Resource centres will be responsible for
  - i. Undertaking HTA studies
  - ii. Capacity building activities like workshops/training programs /on line courses etc
  - iii. Conducting HTA Sensitisation Workshop for State/ Central Government Health Programs and facilitate Adoption of HTA recommendations by State/ Central Government Programs
  - iv. Writing Policy Briefs
4. Criteria for selection of the Resource centres:

The Principal Investigators may have the following criteria-

  - Undertaken Health Economics or Cost effectiveness analysis or costing studies with published data
  - Undertaken Capacity Building on Health Economics or HTA
