This is with reference to the contractual recruitment process of Scientist C & Junior Health Economist (JHE) in Department of Health Research for the information of all applicants. An advertisement was published in Employment News and leading newspapers on 16.09.2023 inviting applications for filling the then 03 vacant posts of Scientist 'C' and 02 post of Junior Health Economist.

- 2. Against this advertisement, 366 applications were received for Scientist C and 46 applications were received for JHE. DHR engaged National Productivity Council (NPC), an autonomous organisation under Ministry of Commerce & Industry, Govt. of India, for the above contractual recruitment process.
- 3. NPC evaluated the applications on the basis of criteria of Age, Qualification and experience prescribed in advertisement and rejected incomplete application / applications not in proper format. The applicants found eligible for post of Scientist C were called for personal interaction through Video Conferencing during 22nd to 27th July 2024 with the interview panel of officials from Department of Health Research and representative of NPC.
- 4. With respect to the contractual position of JHE, It is apprised that none of the applicant was found eligible for the post of Junior Health Economist.
- 5. Based on the educational qualification, experience and personal interaction, a panel of 59 candidates (Annexure-I) has been formed for the post of Scientist C and the contractual vacancies in DHR will be filled from this panel. The panel of candidates will be valid for one year i.e. till 31.08.2025. Presently, 9 candidates have been issued offer of engagement as Scientist C from the panel.
