The Department of Health Research (DHR) was created as a new Department under the Ministry of Health & Family Welfare vide Presidential notification dated 17th September 2007 by an amendment to the Government of India (Allocation of Business) Rules, 1961, with the objective of facilitating a well-functioning health research system in the country. To fulfil its assigned mandate, the Department of Health Research runs various schemes as well as looks after the administration of the Indian Council of Medical Research, which is an autonomous body under the Department of Health Research.

2. Applications are invited from eligible and suitable officers for filling up the posts of Scientist C and D in the Department of Health Research on Deputation (including short-term contract) basis. The number of post may increase or decrease as per the requirement of the Department.
